RELEASE OF LIABILITY

THIS IS A FULL RELEASE OF ALL RIGHTS. PLEASE READ CAREFULLY

The undersigned or the cold or ward of the undersigned desires to take riding lessons from agents or employees of Bridge Acres Stable, Inc. The riding lessons will take place on land owned by David H. and Helen S. Friedrichs and leased to Bridge Acres Stable, Inc. The undersigned is aware and understands that among other things horses may kick, bite, buck, fall, step on toes, or otherwise cause personal injury to persons riding or attending to them. The undersigned is also aware and understands that saddles, bridles, and other equipment related to riding horses may fall and cause personal injury. The undersigned, for himself or herself and for his or her child or ward, hereby recognizes that riding and handling horses may be a dangerous activity and hereby assumes all risks involved therein whether foreseeable or unforeseeable.

While every effort will be made to match the horses to the undersigned's riding ability or to the riding ability of the undersigned's child or ward, the undersigned is aware and understands that exactitude in such matching is impossible and that as a result of mismatching, injury or damage may occur. The undersigned, for himself or herself, and for his or her child or ward, hereby assumes all risks of such matching or mismatching.

RELSASE

The undersigned, for himself or herself, or his or her spouse, legal representatives, heirs and assigns, and for his or her child or ward, hereby releases, acquits, and forever discharges David H. and Helen S. Friedrichs and Bridge Acres Stable, Inc, and their agents, representatives, employees, successors, assigns, and insurers from any and all actions, claims, demands, damages, costs, losses, injuries, expenses, compensation, consequential damages, or any suits at law or equality which may arise from riding or attending to the horses owned or used by Bridge Acres, Inc. or any equipment used in connection therewith or from any condition of the premises owned by David H. or Helen S. Friedrichs and leased to Bridge Acres Stable Inc, including both buildings and grounds used in connection therewith, which release extends to both injury and death resulting there from. This release includes all actions, claims, demands, damages, injuries and causes of action which may result in whole or part, from any negligence of David H or Helen S. Friedrichs, or Bridge Acres Stable Inc, or their agents, servants, or employees.

This release is intended to be as broad and as inclusive as permitted by the laws of the Commonwealth of Pennsylvania. If any portion of this release is invalid, the balance thereof shall continue in full force and effect.

INDEMNITY

The undersigned, for himself or herself, his or her spouse, and for his or her legal representatives, heirs and assigns, hereby agrees to indemnify and hold David H. and Helen S. Friedrichs and Bridge Acres Stable, Inc, jointly or severally harmless against any loss or claim or injury or demand or any suit at law or equity which may be made of or on behalf of the undersigned's child or ward as a result of injury or death resulting from the riding or attending of horses or the use of equipment owned by Bridge Acres Inc, or the condition of the premises including buildings and grounds owned by David H. and Helen S. Friedrichs and in the possession and control of Bridge Acres Stable, Inc which indemnity and hold harmless includes all damages and losses and costs and interest and attorney's fees.

The undersigned acknowledges that he or she has read the foregoing Background, Release, and Indemnity provisions hereof and understands the contents and significance and hereof and hereby executes this Release and Indemnity Agreement of his or her own free act and will.
